## **Fiscal Impact Summary**

This bill allows the court to admit evidence of a previous act of criminal domestic violence in a case or proceeding in which the defendant is accused of such an act.

This bill will have no expenditure impact on Judicial, the Commission on Prosecution Coordination (CPC), or the Commission on Indigent Defense (CID). Judicial, CPC, and CID indicate that any expenses can be managed within existing General Fund appropriations.

## **Explanation of Fiscal Impact**

## **Introduced on December 7, 2021 State Expenditure**

This bill provides that in cases where a defendant is charged with an act of criminal domestic violence the court may admit evidence that a defendant previously committed such an act. This provision does not preclude the court from admitting or considering evidence pursuant to the South Carolina Rules of Evidence.

Judicial. This bill may delay the progression of general sessions, magistrate, and municipal court proceedings if additional evidence is admitted. Judicial indicates that the following number of cases were filed in general sessions in FY 2021-22:
