Fiscal Impact Summary

This bill is expected to have minimal impact on the General Fund that can be absorbed by the Judicial Department within their current appropriations. This bill will have no impact on Other Funds or Federal Funds.

This bill is also expected to have a minimal expenditure impact on municipal governments. Since our office received no responses from the counties surveyed, we cannot determine the expenditure impact on county governments.

Explanation of Fiscal Impact

State Expenditure

This bill includes personal property and certain other buildings or property, such as churches, municipal buildings, ships, and railway cars within the purview of the first, second, and third degree arson statutes. These offenses are heard in General Sessions court.

This bill also allows the Court to issue bench warrants for certain offenders being monitored by Probation, Pardon and Parole who fail to appear for certain civil contempt proceedings.

This bill eliminates some circumstances that would elevate certain drug offenses from first or second offenses to second, third or subsequent offenses.

During fiscal year 2013-2014, there were 205 charges and 101 convictions for arson in the first, second, or third degree in South Carolina state courts.

There is no data available which would allow the Judicial Department to determine how many fewer or additional charges, if any, would be brought as a result of this bill. However, if any additional hearings or trials would be held in General Sessions court as a result of this legislation it is anticipated the Judicial Department would absorb the costs. It is also anticipated that the passage of the bill could impact the General Sessions court docket if additional hearings and trials are held. This bill will have no impact on Federal or Other Funds.

The South Carolina Department of Probation, Parole and Pardon Services indicates this bill would have no expenditure impact on the General Fund, Federal Funds, or Other Funds.

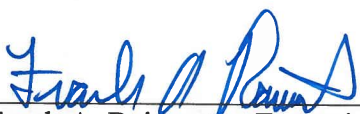
