State Expenditure

This bill establishes that when the parent or parent substitute, sibling, spouse, child, grandparent, or grandchild of a South Carolina Department of Corrections (SCDC) inmate becomes seriously ill to the point of imminent death or dies, provided that SCDC has determined that the inmate poses no security risk, he must be offered the choice to either visit the person in the hospital or attend the person's viewing or funeral service should the location be within state boundaries. SCDC must provide the necessary security and transportation for the inmate and, in doing so, may engage the services of the sheriff of the county in which the funeral or hospital is located. SCDC or the sheriff may collect the actual cost for providing security and transportation from a third party on behalf of the inmate or through a deduction of the inmate's trust account.

Department of Corrections. The agency reports that since the bill allows the agency to collect the actual cost for providing security and transportation for inmates, it will have no expenditure impact on the General Fund, Other Funds, or Federal Funds.

This bill requires the Department of Corrections (DOC) to provide the necessary security and transportation for an inmate to either attend a relative's viewing, funeral service, or, prior to the person's death, visit the person in the hospital.
