Fiscal Impact Summary

This bill may increase Other Funds expenses of the Department of Transportation by \$79,000 for an additional FTE, travel, and supplies if the agency is required to employ a full-time sign language interpreter. The bill may increase General Fund, Other Funds, and Federal Funds expenses for other agencies, but the amount of increase is undetermined. The increase in Other Funds revenue for the Department of Labor, Licensing, and Regulation (LLR) as a result of registration fees for sign language interpreters is undetermined since the registration fee and the number of individuals who will register as interpreters are undetermined. However, the revenue must be used by LLR to defray the expenses associated with the requirements of this bill. The increase in expenses for local governments is undetermined.

Explanation of Fiscal Impact

Introduced on March 14, 2017

State Expenditure

This bill creates the Sign Language Interpreters Act. The bill imposes certain requirements for sign language interpreters used by all departments of state government as listed in Section 1-30-10, offices of statewide constitutional officers, the Judicial Department, all public institutions of higher education, the Commission on Higher Education, police stations, county and state detention centers and correctional facilities, and any other board, commission, or council created by a statute of this state. Additionally, the bill requires LLR to develop and maintain a website and database of all sign language interpreters who are required to register with the department. LLR may charge a nominal registration fee for individuals seeking to register as a sign language interpreter with the department. The registration fees must be used by LLR to defray expenses

associated with the requirements of this bill. LLR has no obligation to verify the credentials of a person registering with the department and may not investigate complaints of misconduct by a person registered with the department. Additionally, LLR may not impose discipline for misconduct as related to the requirements of this bill.

Department of Transportation. The agency indicates that this bill will increase recurring Other Funds expenses by approximately \$79,000 if the agency is required to employ a sign language interpreter on staff. This expense is based upon an average salary of \$50,000, employee benefits of \$22,000, and \$7,000 for supplies and travel.

Department of Motor Vehicles. The agency currently pays \$75 per hour for interpreters who are certified through the School for the Deaf and Blind. The expenditure impact to the agency is undetermined and is dependent upon any increase in interpreter fees as a result in changes to the required qualifications for interpreters.

Department of Alcohol and Other Drug Abuse Services. The agency currently contracts with the School for the Deaf and Blind and South Carolina Interpreting Service for the Deaf, LLC for sign language interpreting services. The agency anticipates that costs for interpreters will increase once individuals gain the certifications and professional hours required by this bill. The expenditure impact to the agency is undetermined and is dependent upon any increase in interpreter fees as a result of changes to the qualification requirements.

State Revenue

This bill authorizes LLR to charge a nominal registration fee for individuals seeking to register as a sign language interpreter with the department. The registration fees must be used by LLR to defray expenses associated with the requirements of this bill. The number of individuals who will meet the requirements of this bill and register as a sign language interpreter are undetermined. Additionally, the registration fee to be charged by LLR is undetermined. Therefore, any increase in revenue to LLR is undetermined.

Local Expenditure

The Revenue and Fiscal Affairs Office contacted twenty-three county governments regarding the expenditure impact of this bill and received no responses. Therefore, the expenditure impact of this bill on local governments is undetermined.
